The Undersigned, on behalf of him/herself and the minor child, if applicable, agrees to indemnify, hold harmless and defend the National Rifle Association of America (NRA) and any employee, director, officer, contractor or agent of the NRA (the Indemnified Parties) from and against any and all fault, liabilities, costs, expenses, claims, demands, lawsuits or any other actions whatsoever arising out of or related to the Activities or any act of omission of the Undersigned. The Undersigned, on behalf of him/herself and the minor child, if applicable, further agrees to release and waive all claims of any kind against the Indemnified Parties arising out of or related to the Activities or any act or omission of the Undersigned. This instrument binds the Undersigned and the minor child and the executors, administrators, assignees or heirs thereof.
- III. This agreement and any disputes arising under this Agreement shall be governed by and construed under the laws of the Commonwealth of Virginia, or, if applicable, federal law. The Undersigned agree that all legal proceedings relating to the subject matter of this Agreement shall be maintained exclusively in courts sitting within the County of Prince William, the County of Fairfax or the city of Alexandria, in the Commonwealth of Virginia. The Undersigned hereby consent to and subject themselves to the personal jurisdiction of such courts and agree that jurisdiction and venue for any proceeding arising hereunder shall lie exclusively with such courts.
